INVITATION TO BID
FOR THE PROCUREMENT OF HIV TEST KITS
(IB 2021-GS-007)

1. The **DOH-CENTER FOR HEALTH DEVELOPMENT CALABARZON**, through the **General Appropriations Act of 2021** intends to apply the sum of **One Million Five Hundred Ninety-Six Thousand Ninety-Six Pesos (P1,596,096.00)** being the ABC to payments under the contract for the **Procurement of HIV Test Kits/IB 2021-GS-007**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DOH-CENTER FOR HEALTH DEVELOPMENT CALABARZON** now invites bids for the above Procurement Project. Delivery of the Goods is **specified in the Schedule of Requirements**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "**pass/fail**" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.


4. Prospective Bidders may obtain further information from **the BAC Secretariat (DOH-CENTER FOR HEALTH DEVELOPMENT CALABARZON)** and inspect the Bidding Documents at the address given below **from 8:00am to 5:00pm, Mondays to Fridays**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 8, 2021 to March 1, 2021** from the given address and website(s) below **and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB**.

6. The **DOH-CENTER FOR HEALTH DEVELOPMENT CALABARZON** will hold a Pre-Bid Conference¹ on **February 15, 2021; 10:00AM** at the 3rd Floor Conference Room, Administrative Building, QMMC Compound, P. Tuazon St., Project 4, Quezon City and/or through video conferencing or webcasting via Webex which shall be open to prospective bidders. Suppliers who are interested to join the virtual Pre-bid Conference may submit their email address and contact numbers to bacsec.doh4a@gmail.com at least three (3) days before the scheduled Pre-Bid Conference.
7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before **March 1, 2021 at 10:00AM.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **March 1, 2021; 10:00AM** at the given address below. ***The Opening of Bids shall be conducted through video conferencing via Webex. Suppliers who are interested to join the virtual Opening of Bids may submit their email address and contact numbers to bacsec.doh4a@gmail.com at least three (3) days before the scheduled Opening of Bids.*** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **DOH-CENTER FOR HEALTH DEVELOPMENT CALABARZON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
